2 HAZARDS IDENTIFICATION

Extremely flammable.

PHYSICAL AND CHEMICAL HAZARDS

Aerosol containers can explode when heated, due to excessive pressure build-up. When sprayed on a naked flame or any incandescent material the aerosol vapours can be ignited.

HUMAN HEALTH

May cause minor irritation on eye contact. Vapours/aerosol spray may irritate the respiratory system. In high concentrations, vapours and aerosol mists have a narcotic effect and may cause headache, fatigue, dizziness and nausea.

4 FIRST-AID MEASURES

INHALATION

In case of inhalation of spray mist: Move person into fresh air and keep at rest. Get medical attention if any discomfort continues.

INGESTION
